### Release and Waiver of Liability

I specifically consent to allow my child to participate in the Baseball Program as a member of the Team, and to the fullest extent permitted by law. I hereby Release, Waive and Covenant Not to Sue, and further agree to Indemnify, Defend and Hold Harmless the following parties: the City of Montrose, Colorado, the State of Colorado, the Baseball Officials, Sponsors, Promoters and Organizers; any Property Owners, Law Enforcement Agencies or Public Entities providing support for the Baseball Program; and each of their respective parent, subsidiary and affiliated entities, officers, directors, partners, shareholders, members, agents, employees, volunteers, successors and assigns (collectively, the "Released Parties" or "Event Organizers"), with respect to any liability, claim(s), demand(s), cause(s) of action, damage(s), loss or expense (including court costs and attorney's fees) of any kind or nature ("Liability") which may arise out of, result from, or relate in any way to mine or my child's participation in the Baseball program, including claims for Liability caused in whole or in part by the negligent acts or omissions of the Released Parties. I further agree that if, despite this Agreement, I, or anyone on my behalf, makes a claim for Liability against any of the Released Parties, I will indemnify, defend and hold harmless each of the Released Parties from any such Liabilities which any may be incurred as the result of such claim.

### Patron Code of Conduct and Photography Waiver

To ensure the safe enjoyment of COM services, all patrons must exercise respect and exhibit appropriate behavior while utilizing COM facilities and programs. Those not following this code may be asked to leave and/or forfeit their authorization to participate. I also consent to COM's use of photos of participants for promotional purposes. This includes photos of any participant for which I am a guardian.
